**PARKING PERMIT RULES AND REGULATIONS**

- Annual, semi-annual and monthly permits are issued in the Clerk's Office.
- ALL permits must be hung from the rearview mirror, facing out.
  - ❖ If there is no rearview mirror on the vehicle, the permit must be placed on the dashboard where it will be visible to the Enforcement Officer.

**NOTE: A summons will be issued if parking permits are not located in acceptable locations. The fact that a current permit was issued will not be accepted as an excuse for its not being displayed properly. Vehicles with permits are not permitted in metered spaces unless money is deposited in the meter.**

- Permits issued for the First Avenue Lot shall only be used in the First Avenue Lot.
  - ❖ Vehicles that park in the First Avenue Lot and do not have a First Avenue permit will be ticketed.
- 40 spots shall be designated in the Savage Rd. Lot to allow commercial vehicles to park overnight with a permit. Commuter vehicles may park in the Savage Rd. Lot during the day at no cost.
- All other permits shall be valid in the Bloomfield Ave., West Main and Mt. Tabor Lots only.

**PERMIT INFORMATION**

1. Permits are required in parking lots from 9:00 a.m. to 6:00 p.m., Monday through Saturday. Parking is free on Sunday. *(Please see note regarding Bloomfield Ave. Lot)*
2. Permits must be displayed as instructed above on the first day that the permit is valid or a summons will be issued. **THERE WILL BE NO GRACE PERIOD.**
3. Hanging permits are transferable from vehicle to vehicle.
4. Denville Township is not responsible for lost permits. An affidavit must be filed in the Denville Township Clerk's Office notifying the Township that the permit has been lost or stolen. A replacement permit will be issued at a cost of **\$50.00**.
5. If a permit is damaged, it must be brought to the Township Clerk's Office. The replacement fee is **\$5.00**.
6. **There is NO REFUND, REBATE, or PRO-RATED FEE for any permit.**
7. Vehicles shall be locked at all times. The Township is not responsible for theft from the vehicle.
8. Denville Township reserves the right to make any additions/deletions to these parking rules and regulations as deemed necessary. A Public Notice shall be placed in the newspaper advising permit holders of the changes.
9. **ANY PERSON WHO ATTEMPTS TO REMOVE, TAMPER WITH OR HINDER PARKING ENFORCEMENT MATERIAL IS GUILTY OF A DISORDERLY PERSONS OFFENSE AND IS SUBJECT TO A MAXIMUM FINE OF \$2,000.**

*Bloomfield Avenue Parking Lot – Permits are required according to the signage at the entrance to the lot. Please note: Requirements subject to change during the year.*
