Control Documents for the above may be examined in the office of the Township Clerk, 1 St. Mary's Place, Denville, New Jersey, 07834, between the hours of 8:00 a.m. and 4:00 p.m., Monday through Friday. Any person, firm, or corporation desiring a copy of the Contract Documents may obtain such from the Township Clerk's Office.

Bidders must use the prepared Proposal Form. Each proposal must be enclosed in a sealed envelope addressed to the Township Clerk, Township of Denville, marked on the outside with the name and address of the bidder and the name of the contract being bid, and delivered on or before the hour set forth above. **NO BIDS WILL BE ACCEPTED AFTER THE BID OPENING HAS COMMENCED.**

The Township of Denville reserves the right to award the contract to the lowest responsible bidder.

Bids must be accompanied by a Consent of Surety, plus a bid guarantee in the form of a certified check, bid bond or cashier's check in the amount of ten percent (10%) of the base bid (based upon the highest of the three (4) proposals submitted using the unit price bid and the estimated tonnage contained in paragraph 5.1 of the contract specifications, as the determining factors), but not in excess of \$20,000.00 made payable to the Township of Denville. A Non-Collusion Affidavit shall also be submitted.

All guarantees of unsuccessful bidders will be returned upon award of contract to the successful bidder.

The successful bidder will be required to furnish a bond for the faithful performance of the contract in a sum not less than 100% of the total estimated price for the completed bid, said bond to be that of an approved surety company authorized to do business in the State of New Jersey, and acceptable to the Township. For a multi-year contract, the successful bidder shall provide a performance bond in an amount equal to the annual estimated value of the contract. The performance bond for each succeeding year shall be delivered to the Township with proof of full payment of the premium 120 days prior to the expiration of the current bond.

Bidding information contained in this Proposal should be clear and not subject to qualifications, deletions, erasures, or other marking that create any doubt as to its meaning. Bidders should make sure that Bid Proposal is signed by a duly authorized person on behalf of the bidder and that the Proposal is responsive. Bidders can determine the responsiveness of their Proposal by reading the specifications. **INSTRUCTIONS**
