- Children must be 5 years old by June 30<sup>th</sup>, to participate in the 2018 Swim Lessons.
- Swim Lessons will be two days per week either Monday/Wednesday or Tuesday/Thursday. Lessons will be offered on the top of the hour from 11:00 am to 5:00 pm. Each lesson will run for approximately 35-40 minutes. **Please choose your preferred 3 day/time combinations.** An e-mail will be sent after evaluations to confirm your child’s designated swim lesson time.

- Make-up Lessons will *only* be held if there are **3 full** lessons canceled due to weather. Please note that make-ups are also at the discretion of the Recreation Director and Pond Manager.
- Students are grouped by ability and called: Tadpole, Crayfish, Frog, Turtle, Catfish, and Dolphin.
- Evaluations: All students will be evaluated prior to the start of swim lessons Evaluations will take place on **Thursday, June 21<sup>st</sup> and Friday, June 22<sup>nd</sup>** between the times of 2 – 6pm, whenever is convenient for you. During this time, each student’s current swimming ability will be assessed and they will be placed into groups by the instructors according to their evaluation. An e-mail will be sent **on or before June 24<sup>th</sup>** to confirm your child’s designated swim lesson time.
